### Introducing Superintendent, Lisa Simpson

I am so pleased to be involved in the work of the NSSCP. Thank you for such a warm welcome into this great team! I lived and worked in the area for some ten years in the early 2000s and have a real soft spot for this community. I have 28 years policing experience and have enjoyed every minute of it even though the content of my work can be tragic, demanding and sometimes unfathomable. I try never to let go of the principle that we have the privilege to walk into people's lives at some of the worst moments and that we can make a huge difference and impact. I have worked in Bristol in Neighbourhood, Response and CID roles and have been involved in training our CID teams, particularly around vulnerability and interviewing. I was promoted to Chief Inspector when I was pregnant with my first child in 2008, so have been involved in the senior leadership roles of Somerset, North Somerset and in Professional Standards and Neighbourhood policing. I have only this year returned to local policing as the Commander for both Somerset and North Somerset. (It's not at all confusing to find different names 'across borders' for the same meetings and project themes! I am, however, loving the challenge.)

Most recently, I was the lead for the constabulary's approach to improving our service and outcomes to victims and perpetrators of rape (Operation Bluestone). I am hoping to share learning from the work in this project throughout my new role, which shone a light on so much about investigating vulnerability-based crimes. I am most proud though of my family – a husband who has given passionate service to constabulary for 45 years and our children: Freya (14) and Harry (16) who go to school in Taunton. Their patience with my slightly sprawling and chaotic working life is quite humbling!

## ICON Training



<b>I</b>	Infant crying is normal and it will stop! Babies start to cry more frequently from around 2 weeks of age.
<b>C</b>	Comfort methods can sometimes help to soothe the baby and the crying will stop.
<b>O</b>	It's OK to walk away if you have checked the baby is safe and the crying is getting to you. After a few minutes when you are feeling calm, go back and check on the baby.
<b>N</b>	Never, ever shake a baby. It can cause lasting brain damage and death.

ICON is an evidenced-based programme aimed at preventing abusive head trauma injuries to babies caused by shaking - also referred to as 'shaken baby syndrome'. Knowing and understanding the ICON message will help you as professionals deliver key messages to parents and carers, to help them understand the normal crying pattern of young infants and give them the tools and interventions to develop successful coping mechanisms.

This training is FREE to all and we want to reach a wide variety of professionals and volunteers. **If you work with families, children, carers, parents or even briefly come across these groups of people, this training is for you.**

These sessions will be offered every other month and across a variety of times.

Many thanks to Fiona Bennett, Safeguarding Lead for sharing her experience...

*'As schools, one of the challenges we face is not receiving a response to issues or referrals that we raise with other agencies especially when there has been a fluctuation of staff. In the past, we have spent lots of time trying to chase up information or get answers with no clear or consistent way to have our issues heard. In a meeting with the local authority, we shared our frustrations, and the **Issue Resolution Policy** was shared and discussed. As a MAT we shared this amongst our DSL's team and the feedback from those initiating this has been that following this policy has helped us get the information that we need, and the response was swift with actions put in place for the benefit of the children and young people.*

*My advice is to log any times that you attempt to make contact or receive contact that doesn't address your request and use this policy as a way of ensuring you start a conversation with the relevant team. This has helped us to ensure that situations don't escalate or concerns aren't dismissed.'*
