In my safeguarding career, I've seen the benefits of agencies and organisations coming together to deliver the best possible services for children, young people and families and am committed to making this happen here.



Free Webinars: County Lines and Gangs

Free professional awareness webinars hosted by St Giles Trust and funded by North Somerset Violence Reduction Partnership. The webinars will take place on Wednesday **26th March 2025** at the following times:

- 10:00 am 12:00 pm
- 4:00 pm 6:00 pm

Speakers with first-hand experience of the criminal justice system will explore how county lines operate, how young people are groomed and exploited, and the risk factors that make them vulnerable. The session will help professionals recognise the signs of exploitation and understand the links between county lines and other forms of criminal activity, such as serious violence, modern slavery, and child sexual exploitation.
