Multi-Agency Child Protection

Level 1 : Basic Awareness

Who is this for?

All staff and volunteers who have some contact (direct or indirect) with children in their role. *

Course outcomes

How to identify and spot the signs and symptoms of abuse and neglect in children. Understanding the levels of support available to families in North Somerset and build confident in knowing what to do if you suspect a child is being abused or neglected.

***Once you have completed this course to remain compliant you should complete a 1.5 hour e-learning refresher annually.**



Our Core Offer

Multi-Agency Child Protection

Level 2 : Intermediate Awareness

Who is this for?

Staff and Volunteers who have completed level 1 and/or who work frequently with children. Those with specific Safeguarding responsibilities or working towards becoming Designated Safeguarding Lead

Course outcomes

Introduction to local and national safeguarding policies and procedures including the Continuum of Need.

An examination of how professionals assess risk and need alongside opportunities to explore tools for identifying need, risk and harm.

Multi-Agency Child Protection

Level 3 : Advanced Awareness

Who is this for?

Staff and volunteers who have completed level 2 and have extensive contact with children. Those who are working towards becoming Designated Safeguarding Lead for their agency.

Course outcomes

Exploration of the contribution of multi-agency colleagues to child protection decision making, including making Requests for Support, contributing to Assessments, Investigations, Child Protection Conferences and Safety Planning.

Multi-Agency Child Protection

Level 3 : Advanced UPDATE

Who is this for?

This course is for those who have completed the level 3 Advanced Course. *

Course outcomes

Updates on the latest changes to policies, procedures and legislation. Introduction to tools for practitioners to identify and manage risk.

Learnings from Practice Reviews and exploration of relevant issues or emerging trends across safeguarding such as neglect, domestic abuse and risk outside the home.



£50 - (for non partnership delegates)

Half Day

Online and Face to Face

Delivered up to 6 times per year.

***If you have specific safeguarding responsibilities or are a Designated Safeguarding Lead you should complete this course every 2 years. Otherwise we recommend completing it every 3 years.**

Understanding the cumulative impact of Neglect on Children

Who is this for?

Staff and volunteers who work directly with or have designated safeguarding responsibility for children.

Course outcomes

Identifying signs and symptoms of neglect in children from pre-birth to adolescence and the context in which neglect can occur.

Introduction to the North Somerset Early Help Strengths and Needs Tool Kit for use with families to identify strengths and areas where targeted support may be required at the earliest opportunity.

of abuse or neglect, the role of
adult social care and use of
capacity assessments and other
tools to help keep older people
safe.

Exploration of what Coercive and Controlling Behaviours might look like in the context of Domestic Abuse.

Examining new and updated legislation and guidance in this area as well as tools to assist with identifying the support available when these behaviours are present in any relationship.

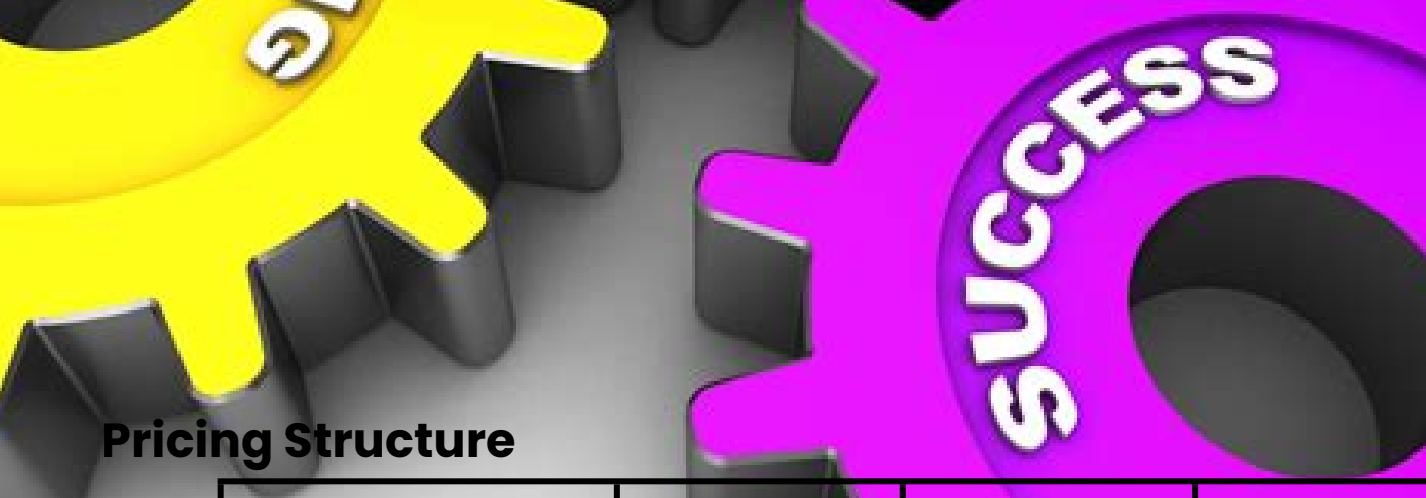

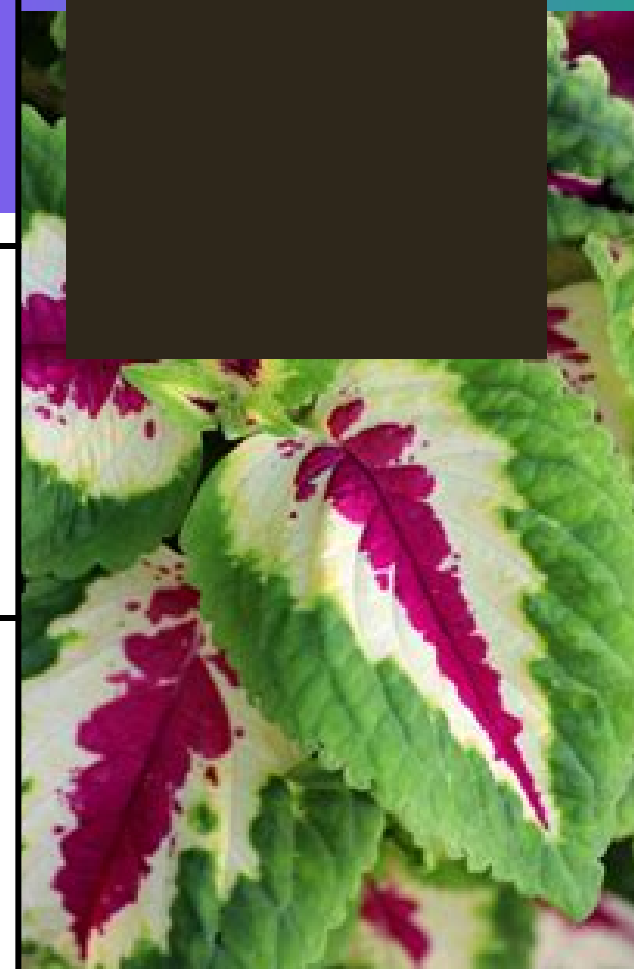
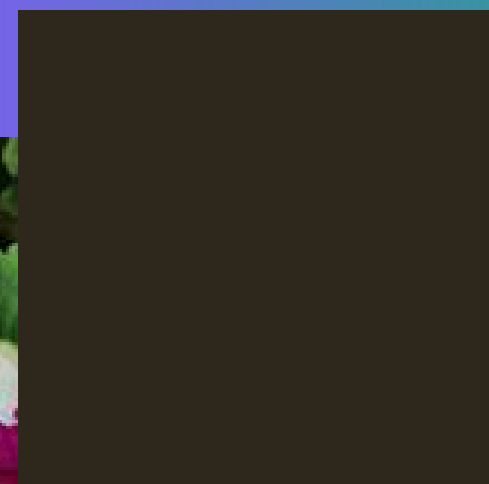

Terms and Conditions

Bookings and Cancellations

Individual delegates must have an account on the IlearnTogether training portal.

Bookings made by individual delegates are transferable within the relevant agency.

To confirm attendance delegates must sign the register provided on arrival at face to face courses, or display full names on screen if delivery is online.

Confirmation of attendance is also dependant on completion of post course evaluation.

If delegates cannot attend they must cancel their place via i-learn **at least 10 working days** prior to the course delivery date.

The Partnership reserve the right to cancel advertised training sessions due to low delegate numbers, staff sickness or any other unforeseen circumstances.

Should your course be cancelled we will make every effort to give as much prior notice as possible and bookings for cancelled courses are transferable to other available dates.



Terms and Conditions

Fees and Charges

Delegates from Partnership Agencies* can attend all courses **free of charge**.

Where specified, attendance fees only apply to delegates from non-partnership agencies.

If advertised as **free to attend** this applies to all delegates.

Agencies will be invoiced for payment once attendance has been confirmed.

***Partner Agencies are:**
North Somerset Council
Avon and Somerset Police (Including Avon Fire and Rescue)
North Somerset NHS services (Including Sirona)

Delegates who do not attend or fail to cancel within the specified notice period will be invoiced for the full attendance fee. *

Non-attendance fees apply to all delegates and all courses.

If the training is cancelled by the Partnership no fees or charges will be applied.

***Reasonable reasons for late cancellation will be considered.**





Other Terms and Conditions

Bespoke training can be booked directly via the training team and will be invoiced according to individual agency requirements

Refreshments will be provided for delegates attending face to face training.

We encourage delegates to bring their own reusable cups to cut down on waste.

Food is not provided for any courses, therefore delegates will have to provide their own.
