#### What's changed?

Updates are marked in red and explain what to include in the email subject line when submitting your referral.

#### What to include in your email subject line:

Clearly state whether your referral is for "Family Wellbeing" or "Children's Social Care".

Include the scaling score (0–10) from your referral. **Example:** Family Wellbeing 4.

## The links between poverty and domestic abuse in child protection

Community Care has published an [article](#) outlining findings from the 'rethinking domestic abuse in child protection' ([RDAC](#)) research project.

The article highlights that there is a 'social gradient' in children's chances of going into care: those in the poorest areas of England were over ten times more likely to be looked after than those in the most affluent areas, and that domestic abuse was an important factor in this; yet, the system often failed to recognise and examine how inequalities shaped families' experiences and needs.

## Smartphones and their impact on children's mental health

Research shows that social media and the messages children receive during their formative years can shape their beliefs about themselves and the world around them.

The Association for Child and Adolescent Mental Health (ACAMH) has [published a film](#) exploring some of the potential dangers of smartphones and social media on children's mental health and share practical advice on how to support children's wellbeing.

The film features children discussing their own experiences, plus contributions from the PAPAYA charity, a secondary school headteacher and a primary school headteacher, offering valuable insights from both clinical and educational perspectives.

## How Ofsted looks at AI during inspection and regulation

Ofsted has released a statement on how they will view the use of AI in settings they are inspecting. Starting from a position of support for the use of AI where it improves the education and care of children, Ofsted will consider the impact of AI on outcomes and how risks such as data protection and accuracy are managed. Within this there will be consideration of how individuals and settings are safeguarded.
